

# **COURT OVERVIEW**

#### Foreword

Pursuant to R.C. 1901.14, I submit the 2020 Annual Report of the Willoughby Municipal Court. Throughout the COVID-19 global health pandemic, the Willoughby Municipal Court remained open and fully functioning at all times. The pandemic highlighted the important work of the judiciary. This Court marked the following outstanding achievements:

- Preliminary certification for the Veteran's Court specialized docket
- Implementation of a new case management system, allowing for e-citation and e-filing
- Revamped, user-friendly website
- Fully upgraded technology in both courtrooms, including addition of "mobile courtroom" technology cart

## Veteran's Court Specialized Docket

Willoughby Municipal Court becomes the first specialized docket in Lake County focusing on the needs of Veterans. The Court applied for certification of the Veteran's Court specialized docket and initial certification from the Ohio Supreme Court has been received.

The specialized docket will provide Veterans with the opportunity to develop job skills, connect to VA services, engage in treatment, stabilize their living situations, and reconnect with Veteran peers. The docket relies on a partnership with the VA Northeast Ohio Healthcare System, the Lake County Veterans Service Commission, other local veteran service groups and peer to peer mentoring. Participants of the program are required to sign an agreement that outlines expectations, in addition to consequences for noncompliance. The Court expects to continue the certification process in 2021.

## Operations

Court staff was on site every day in 2020 to maintain daily functions. Daily operational needs requiring staff presence include processing citations, criminal and civil complaints, arraignments, bond hearings, temporary protection order hearings, preliminary hearings, and warrants. All of these functions require on-site staff to process the appropriate paperwork and schedule.

At the start of the pandemic, the Court quickly adjusted to remote hearings and use of telepresence technology to continue court business. We implemented internal safety measures to ensure the health of staff, attorneys, police officers, and the public, while continuing the important business of the court. Throughout the year, the processes were adjusted to accommodate the challenges of COVID-19. Probation staff implemented remote communications, when possible, with probationers. Some of the remote communications with probationers will continue beyond COVID-19, as the new practices provide for more effective use of time.

In October 2020, the Court began implementation of a new case management system and website. This transition was timely, given the COVID-19 pandemic and encouragement from the Ohio Supreme Court to utilize technology. Court staff worked on testing and preparing for the conversion. Local police departments began utilization of e-citations. The transition has brought the Court into a nearly paperless court environment. This conversion is still ongoing, with the goal of e-filing in 2022.

#### Budget

COVID-19 drastically altered the number of new civil, traffic, and criminal case filings within the Court. Additionally, due to the Ohio Supreme Court Tolling Order and corresponding legislation, the Court stopped sending cases to collections from March through July of 2020. The lack of new cases and the inability to collect unpaid fines and costs had a direct impact on the court allocation.

The Court incurred additional expenses related to COVID-19 such as the purchase of personal protective equipment, plexiglass for modified work stations, additional disinfecting and cleaning services, and increased postage and paper costs.

Staffing levels are determined by what the Court deems reasonable and necessary to the administration of the Court's business. Throughout the pandemic, all full-time employees remained working throughout 2020. Part-time employees worked only as needed and there were no summer hires. Some staffing vacancies remained unfilled. Although allocated in the 2020 budget, court staff did not receive any pay increase in 2020 or any "hazard pay" for

continuing to work throughout the pandemic. This decision was made in light of the uncertainty of the pandemic and projected increased expenses.

The Court was not eligible for direct receipt of Coronavirus Aid, Relief, and Economic Security ("CARES") Act funding; however, municipalities and villages within the Court district received over 13 million dollars in relief funding. Of this funding, the City of Willoughby allocated approximately \$80,000.00 in CARES funding to the Court. These funds were used for wages and benefits for administrative leave and EPSL assistance and to offset the COVID expenses previously listed. Additionally, the Court received a refund of approximately \$82,000.00 from the Bureau of Workers' Compensation in 2020.

The Court applied for and was awarded two technology grants from the Ohio Supreme Court, totaling just over \$70,000.00. The funds were used to address aging technology within the court and adapt to the Ohio Supreme Court's directives in the use of technology. The Court purchased upgraded remote systems, laptops, screens, and electronic signature pads. Also purchased was a "mobile courtroom" technology cart. The cart consists of a monitor, camera and computer to allow for complete remote communications. The cart is used for hearings, attorney/client conferences for incarcerated individuals and employee trainings throughout the building.

#### Acknowledgements

The hard work of our capable and dedicated court staff must be commended. Court staff was flexible and made adjustments to processes, sometimes daily. In addition to the challenges of COVID-19, staff shifted to an entirely new, electronic case management system. In a regular year, this would have been a demanding task. Staff worked diligently and consistently, even when understaffed at times, to ensure the administration of justice. Their commitment to the Court and the people we serve is admirable.

Our local justice stakeholders also deserve recognition for their efforts and energy. This includes local law enforcement agencies; city prosecutors and the Lake County Prosecutor's Office; the Lake County Public Defender; the Lake County Clerk of Court; and the Lake County Bar Association and members of the bar. These groups all worked in cooperation with each other and the Court to adjust to the many changes of 2020. Their cooperation and commitment to justice is essential to the process and integrity of our system of justice. The Lake County Sheriff's Office and their staff also has to be acknowledged. Sheriff Leonbruno and Chief Deputy Sherwood were instrumental in the facilitation of remote hearings from the Lake County Jail. Corrections officers at the jail worked daily with the Court, for hours at a time, to ensure that all incarcerated individuals were able to speak with counsel and be presented to the Court for hearing. This was often a very long, tedious process that the Sheriff and staff handled with complete professionalism.

Finally, thank you to the City of Willoughby, Mayor Fiala and his staff. The Court relied upon the assistance of the City of Willoughby Finance and Service Departments throughout the year. Their work is especially appreciated in a year where we faced many challenges in both areas.

## Conclusion

As always, I will continue to ensure that Court practices remain fully compliant with constitutional standards and that we continue to act in a manner that increases confidence in the fairness of our justice system. I will work each and every day to administer justice, in an effort to maintain the integrity and impartiality of the judiciary.

Judge Marisa Cornachio was elected to serve a six-year term as Judge of the Willoughby Municipal Court beginning January 1, 2018.

Judge Cornachio was selected by Chief Justice O'Connor to serve on the Pretrial Justice Reform Summit Planning Committee. She currently serves on the Ohio Supreme Court's Commission on Continuing Legal Education and previously served on the Court's Commission on Certification of Attorneys as Specialists.

Judge Cornachio is a member of the Ohio Judicial Conference and serves on the committees for Judicial Ethics, Professionalism



and Diversity, Judicial Education and Criminal Law and Procedure. She is a member of the Ohio Municipal Judges Association and the Lake County Bar Association. Judge Cornachio serves on the Lake County Corrections Board, the Lake County Law Library Resource Board and the Lakeland Community College Advisory Committee. She is a volunteer for the Ohio High School Mock Trial program.

Prior to taking the bench, Judge Cornachio was an assistant Lake County Prosecuting Attorney and was appointed as a Special Prosecuting Attorney for over five years in conflict cases. She has extensive jury trial and courtroom experience prosecuting felony offenders. Her practice of law included small business advisory and representation of clients in municipal and common pleas courts throughout the State of Ohio. Judge Cornachio was an adjunct professor at Lakeland Community College, teaching a variety of legal courses to paralegal students.

Judge Cornachio earned her B.A in Political Science from The Ohio State University and her J.D. from Cleveland-Marshall College of Law.



# PROBATION

As my first year as Chief Probation Officer, I am honored to present to you the 2020 annual review from the probation department. This report sheds light on the outstanding work that the department staff does on a

regular basis, along with achievements that were reached during this year. This Court's probation department continues to be a leader in community corrections, working with the judiciary and community to create a safer society. We are committed to providing the court with quality and reliable information and to offering viable, cost-effective pretrial and sentencing options. Through a balance of enforcement and treatment strategies, we hold offenders accountable and offer them opportunities to become productive, law abiding citizens. Each probation officer embodies professionalism and values the needs of each offender. The department utilizes the evidence-based practice method, which has been recommended by the Ohio Supreme Court.

During 2020, the department supervised 702 offenders, completed 52 presentence reports, 186 probation violations, and issued 520 drug screens. Community service continues to be an effective way for offenders to give back to the community. During this calendar year 5,899 community service hours were completed. To protect the public from individuals that were charged or convicted of an OVI (Operating Vehicle Intoxicated) offense, the Court frequently orders regular monitoring using a SCRAM unit which can detect the presence of alcohol at the surface of a person's skin. The probation department conducted 137 SCRAM referrals and had a compliance rate of 99.1%, measuring sober-day success rate of all the participants in the program nearly 100%. The Court also provides house arrest as a tool to closely monitor offenders. During this year 39 offenders were monitored on house arrest.

Our probation staff continues to be active members with various professional organizations such as Ohio Chief Probation Officer's Association, American

Probation and Parole Association, Northeast Ohio Probation Officer's Association, Lake County Corrections Board, and Ohio Judicial Alliance for Community Corrections. Staff completed various forms of training with the Ohio Supreme Court and the United States Department of Justice.

Looking ahead to 2021 and beyond, the Willoughby Municipal Court Probation Department is committed to closely monitoring individuals that are on probation virtually using OCSS (Ohio Community Supervision System). This computer-based program will allow officers to interact with other probation departments regarding offenders and utilize other tools such as text message appointment reminders. The department will also begin supervising and monitoring offenders that are placed in the Willoughby Municipal Veteran's Treatment Court.


