

# **COURT OVERVIEW**

### Foreword

Pursuant to R.C. 1901.14, I submit the 2022 Annual Report of the Willoughby Municipal Court.

We have finally turned the corner, leaving the global pandemic in our rear-view! We have taken a critical look at court operations in a post-COVID world. We have thoughtfully considered technology and security, and the role they play in court operations. The Court convened its Security Advisory Committee on two occasions in 2022. The committee is comprised of local community officials, leaders in law enforcement and emergency services, attorneys and other justice stakeholders. The committee reviewed the security standards as set forth by the Ohio Supreme Court and compared them to current security protocols. The Court and its local partners will continue to diligently work for the safety of all who enter the courthouse.

Court caseload is on the rise, with an increase in the complexity of matters coming before the Court. Changes in the law continue to increase responsibilities of local courts and ours is no exception. Our staff continues to work diligently to follow the law and meet the demands of justice.

Valuable time was spent engaging with community members about the importance of the justice system, courts, and the rule of law. The Court hosted student visitors from schools in and around the court district, including Lakeland Community College. We also hosted several students for their senior projects. I began participation on the Lake County Opiate Task Force and continued as a member of the Lake County Corrections Board, the Lake County Law Library Resource Board, Lakeland Community College Advisory Committee and the Lake County Bar Association. It was an honor to be elected to serve as a Trustee to the Association of Municipal and County Judges of Ohio. This organization represents municipal and county judges in the State of Ohio. The association also provides a judicial perspective to members of the Ohio General Assembly regarding legislation impacting municipal and county courts. I continued work with three committees for the Ohio Judicial Conference: Criminal Law and Procedure, Judicial Ethics, Professionalism & Diversity and Judicial Education. I was also re-appointed by the Ohio Supreme Court to serve a second term as a member of the Commission on Continuing Legal Education.

A highlight of the year was the Court's first graduation ceremony for participants on the Veteran's Treatment Docket. The momentous occasion was marked with honored guest and keynote speaker, Ohio Supreme Court Chief Justice Maureen O'Connor. A longtime champion of specialized dockets, the chief justice has seen the number of support and recovery court programs grow since the certification process began. The premise of the Veteran's Treatment Specialized Docket is to hold offenders accountable for their actions while addressing underlying causes of behavior, such as substance use, mental illness, and struggles with everyday needs, such as food, housing, and employment. The Court works with its community partners, treatment facilities and social service organizations, to customize recovery plans based on participants' needs.

#### Acknowledgements

The important work of the judiciary relies on the dedication of court staff and local justice stakeholders. They all should be commended for their efforts. Our staff works daily with local law enforcement agencies, the Lake County Sheriff's Office, city prosecutors and the Lake County Prosecutor's Office, the Lake County Public Defender, the Lake County Clerk of Court, and members of the bar. These groups are essential to the process and integrity of our system of justice.

Finally, thank you to the City of Willoughby and Mayor Fiala, and the Willoughby Police Department for their support and assistance.

### Conclusion

As always, I will continue to ensure that Court practices remain fully compliant with constitutional standards and that we continue to act in a manner that increases confidence in the fairness of our justice system. I will work each and every day to administer justice, in an effort to maintain the integrity and impartiality of the judiciary.

### About the Judge

Judge Marisa Cornachio was elected to serve a six-year term as Judge of the Willoughby Municipal Court beginning January 1, 2018. Judge Cornachio is the Administrative and Presiding Judge of the Court, where she oversees the administration of all criminal, civil, forcible entry and detainer actions, and small claims filings originating on the west end of Lake County. In addition, Judge Cornachio established and presides over the Willoughby Veterans Treatment



Court, Lake County's first specialized docket that focuses exclusively on the unique needs of veterans. The specialized docket received final certification from the Ohio Supreme Court in 2021.

In 2022, Judge Cornachio was elected by her peers to serve as a Trustee to the Association of Municipal and County Judges of Ohio. She is a member of the Ohio Judicial Conference and serves on the committees for Judicial Ethics, Professionalism and Diversity, Judicial Education and Criminal Law and Procedure.

Judge Cornachio was appointed by the Supreme Court of Ohio to serve on the Commission on Continuing Legal Education. She previously served on the Court's Commission on Certification of Attorneys as Specialists. She was selected by Chief Justice O'Connor to serve on the Pretrial Justice Reform Summit Planning Committee.

#### About the Judge (con't)

Judge Cornachio is a member of the Lake County Opiate Task Force and the Lake County Bar Association. She serves on the Lake County Corrections Board, the Lake County Law Library Resource Board and the Lakeland Community College Advisory Committee. She has been a volunteer for the Ohio High School Mock Trial program.

Prior to taking the bench, Judge Cornachio was an Assistant Lake County Prosecuting Attorney and was appointed by the Lake County Court of Common Pleas as a Special Prosecuting Attorney for over five years in conflict cases. She has extensive jury trial and courtroom experience prosecuting felony offenders. Her practice of law included small business advisory and representation of clients in municipal and common pleas courts throughout the State of Ohio. Judge Cornachio was an adjunct professor at Lakeland Community College, teaching a variety of legal courses to paralegal students.

Judge Cornachio earned her B.A in Political Science from The Ohio State University and her J.D. from Cleveland-Marshall College of Law.



# PROBATION

I am proud to present to you, the Willoughby Municipal Court Probation Department 2022 Annual Report.

In August, 2022, the Probation Department was met with a new Chief of Probation. The Probation Department continued to offer community resources to serve as a bridge between the community and our law enforcement and court liaison partners.

Additionally, in August, 2022, the Willoughby Municipal Court Veterans Court under the supervision of the Probation Department, celebrated the first graduation from its Treatment Court. The Court was honored to host the Ohio Supreme Court Chief Justice Maureen O' Connor as the keynote speaker for the graduation ceremony. The Willoughby Municipal Court Veterans Treatment Court Docket continues to grow with their communitybased partners. This program was certified in 2021 by the Ohio Supreme Court as an official specialized docket.

The department supervised 670 offenders. The probation department investigated and completed 81 Pre-Sentence Reports to present to the Court before sentencings.

There were 241 probation violations, and the department issued 2,743 drug screens. Tracking 2,890 hours of community work service, this has become a tangible way the department was able to convert offenders obligations' to the Court into a tangible, substantive restitution to the community. The department works with more than 45 community agencies for community work service referrals.

The Court continues to also order monitoring of those charged or convicted of an offense involving alcohol, or Operating a Vehicle While Intoxicated (OVI), using a SCRAM brand unit which can detect the presence of alcohol at the surface of a person's skin. The probation department monitored 182 clients on a Continuous Alcohol Monitoring (CAM) Device for a total of 13,902 days. Our department reached a 98.4% Sober Days rating, meaning of the 13,902 days our clients were monitored, 98.4% of them were quantifiably sober! The 2022 national average was 98.9%.Clients in our CAM program participated for an average of 76 days.

Furthermore, in direct response to need for a number of offenses, the Court also utilizes GPS Monitoring. This allows for persons to be monitored by the Probation Department and while simultaneously work to support their families, and pay the taxes to the communities. The device will track the Defendant's location in real time and immediately notify the monitoring company of any violations, including if they try to tamper or remove the equipment. This can work similarly to protect victims of violent crimes.

#### **PROBATION (CON'T)**

In 2022, the Willoughby Probation Department clients were monitored on GPS for a total of 6,714 days.

The Probation Department supervised 162 individuals under the Court's two Diversion Programs; the First Offender Program and the License Diversion Program. While there is no "one size fits all" approach, the department works with each defendant on each case and specifically addresses their individual needs. By avoiding

a criminal conviction record and making amends to victims in the community, they focus on the problem, reserve Court resources, and efficiently resolve cases. Additionally, working with the defendants in obtaining and maintaining their driver's license facilitates the promotion of safe driving and legal vehicular responsibility and operation.


