COURT OVERVIEW

Foreword

Pursuant to R.C. 1901.14, I submit the 2023 Annual Report of the Willoughby Municipal Court.

2023 was a productive year in the Court. We remain one of the busiest single judge courts in the State of Ohio. As such, we are diligent in evaluating process and operations by considering the following performance areas: access to justice; expedition and timeliness; equality, fairness and integrity; independence and accountability; and public trust and confidence.

Court caseload is holding steady; however, matters before the Court remain complex. Changes in the law continue to increase responsibilities of local courts and ours is no exception. Our staff continues to work diligently to follow the law and meet the demands of justice.

The Court earned final re-certification of the Veteran's Treatment Court from the Ohio Supreme Court's Commission on Specialized Dockets. The docket is Lake County's first specialized docket focusing on the needs of Veterans. The premise of the Veteran's Treatment Specialized Docket is to hold offenders accountable for their actions while addressing underlying causes of behavior, such as substance use, mental illness, and struggles with everyday needs, such as food, housing, and employment. The Court works with its community partners, treatment facilities and social service organizations, to customize recovery plans based on participants' needs.

Valuable time was spent engaging with community members about the importance of the justice system, courts, and the rule of law. The Court hosted student visitors from schools in and around the court district, including Lakeland Community College. We also hosted several students for their senior projects.

stakeholders. They all should be commended for their efforts. Our staff works daily with

local law enforcement agencies, the Lake County Sheriff's Office, city prosecutors and the

of our system of justice.

About the Judge

Judge Marisa Cornachio has been elected to serve as Judge of the Willoughby Municipal Court since 2018. Judge Cornachio administers one of the busiest single-judge Court dockets in the State of Ohio. She is the Administrative and Presiding Judge of the Court, where she oversees the administration of all criminal, civil traffic and small claims cases from the west end of Lake County. In addition, Judge Cornachio established and presides over the Willoughby Veterans Treatment



Court, Lake County's first specialized docket that focuses exclusively on the unique needs of veterans.

In 2024, Judge Cornachio was elected by her peers to serve as Secretary of the Association of Municipal and County Judges of Ohio. She is a member of the Ohio Judicial Conference and serves on the committees for Judicial Ethics, Professionalism and Diversity, Judicial Education and Criminal Law and Procedure.

Judge Cornachio was appointed by the Supreme Court of Ohio to serve on the Commission on Continuing Legal Education. She is a member of the Lake County Opiate Task Force and the Lake County Bar Association. She serves on the Lake County Corrections Board, the Lake County Law Library Resource Board and the Lakeland Community College Advisory Committee. She has been a volunteer for the Ohio High School Mock Trial program.

Prior to taking the bench, Judge Cornachio was an Assistant Lake County Prosecuting
Attorney and was appointed by the Lake County Court of Common Pleas as a Special
Prosecuting Attorney for over five years in conflict cases. She has extensive jury trial and
courtroom experience prosecuting felony offenders. Her practice of law included small
business advisory and representation of clients in municipal and common pleas courts

throughout Ohio. Judge Cornachio was an adjunct professor at Lakeland Community College, teaching a variety of legal courses to paralegal students.

Judge Cornachio earned her B.A in Political Science from The Ohio State University and her J.D. from Cleveland-Marshall College of Law.



PROBATION

Presented to you is the Willoughby Municipal Court Probation Department 2023 Annual Report.

It is the duty of this Probation Department to serve the Court in the administration of justice, help protect the community, and encourage individuals to be valued members of society.

The department supervised over 550 offenders and completed over 50 Pre-Sentence Reports. There were less than 200 probation violations, and the department conducted over 1,700 controlled substance screens.

The department coordinated nearly 2,500 hours of community work service. This has become a tangible way for the department to convert an individual's obligations to the Court into a substantive restitution to the community. The department partners with numerous community agencies within Lake County and surrounding area for community service referrals.

The Court continues to order monitoring of those charged or convicted of an offense involving alcohol. The probation department monitored over 100 clients on a Continuous Alcohol Monitoring (CAM) device and obtained a 99% Daily Compliance rating.

Furthermore, the Court utilizes Global Positioning System (GPS) monitoring. The electronic GPS device will track an individual's location in real time and immediately notify the monitoring company of any violations, including attempts to tamper or removal of equipment. This allows for individuals to be monitored by the Probation Department and assist in protecting victims.

HOURS OF COMMUNITY SERVICE

The Probation Department supervised nearly 200 individuals under the Court's First Offender Program and License Diversion Program. The department works with individuals on each case and addresses their specific needs. By avoiding a criminal conviction and making amends to victims in the community, the individual and officer utilize Court resources, and efficiently resolve cases. The Probation Department completed over 140 Motion to Seal Reports, furthering in the assistance of removing potential barriers. Working with individuals in obtaining and maintaining a valid driver's license facilitates the promotion of safe driving and legal vehicular responsibility, once more removing a potential barrier. The Probation Department issued over 700 driving cards for those individuals granted driving privileges.

The Willoughby Municipal Court Probation Department will continue to serve this community with integrity and professionalism.


